

KENT D. ANDERSON MEMORIAL SCHOLARSHIP FUND GUIDELINES LAKESIDE PRESBYTERIAN CHURCH

1. Scholarships are to be awarded to Active Members, Affiliate Members, and Friends of Lakeside Presbyterian Church.
2. To be eligible, each applicant must:
 - a. be a full-time student in an accredited college or university.
 - b. be a junior or senior during the fall quarter or semester at the time the scholarship money is received.
 - c. be in one of the following fields of study: engineering, math, music or one of the sciences.
3. Friends of Lakeside Presbyterian Church are only eligible to apply if they have not received other scholarships, grants or financial aid exceeding \$10,000 for the year in which this scholarship is received (exclusive of student loans).
4. Application is made by submitting the following items listed in points *a* and *b* to the Scholarship Committee **NO LATER THAN JUNE 1ST:**
 - a. The application form (available from the Church Office) along with:
 - i. college transcript (sent from the college directly to LPC).
 - ii. written statement about the applicant's goals.
 - iii. written statement about the chosen field of study.
 - b. Letters of reference or recommendation from each of the following:
 - i. A college professor addressing the student's performance, quality of course work completed, and academic performance in a college or university.
 - ii. A non-related adult, as a character reference.
 - iii. A Lakeside Presbyterian Church elder or minister, addressing the applicant's church involvement, role model potential for other young church members, potential for success in school, goals, and character.The above letters must be received prior to the interview.
 - c. Interviewing with the Scholarship Committee and answering questions determined by the committee.
5. The Scholarship Selection Committee will consist of the Lakeside Presbyterian Church Memorial Committee. The decision to award a scholarship will be made by a majority vote of said committee.
6. The scholarship award is a minimum of \$500 per year, renewable each year of schooling to a maximum of three years, provided performance meets standards listed below. **STUDENT MUST SUBMIT LETTER OF RENEWAL NO LATER THAN JUNE 1ST.** Funds will be paid at the beginning of each school year.
7. Scholarship recipients must:
 - a. Maintain a cumulative grade point average of 3.0 or better (on a scale of 4.0).
 - b. Be a full-time student according to the credit load defined by the college or university or under special circumstances to be approved by the Scholarship Selection Committee, be a part-time student.
 - c. Be making progress toward completion of the stated education goal (e.g. degree).

- d. Scholarship recipient must have transcripts sent directly from the school registrar's office to the Scholarship Selection Committee at the end of the spring quarter/semester preceding the request.

Withdrawal of scholarships will be determined by the Scholarship Committee during the review session.

In December of each year, the Clerk of Session will inform the chairperson of the Memorial/Scholarship Committee the available amount of earnings for the scholarship award(s).

The presiding Elder will announce the opportunity to apply with full information to be published in the April issue of the Presbynews and church bulletin in May. A short reminder of the June 1st deadline will be published in the May issue of the Presbynews and one church bulletin in the month of May.
